In this edition we inform you of a disturbing event that should never have been allowed to happen and we highlight the new National Workers Memorial. # TOXIC WASTELAND DISGRACE

In the past few months it has come to light that a company, which was fully licensed for demolition and asbestos removal, had not been doing the right thing. They had been dumping the waste on their site and, mixed with other materials, is large amounts of asbestos.

It has been found that these mounds of material, some of which are 4 metres high, have a great deal of asbestos sheets and broken pieces mixed with other waste. Also there appear to be unsecured containers of asbestos insulation both in drums and deteriorating plastic bags. This has been going on for a year and credit must go to the **CFMEU** for bringing it to the attention of SafeWork SA and the public in general.

This issue is unbelievable in this day and age, particularly as this company held an unlimited licence to handle asbestos. The mind boggles at the number of people who would have been exposed to asbestos fibres, both workers and anyone who may have been in the vicinity of this place.

The company is now in administration and the question now is **"who pays to have this site cleaned up?"** The taxpayer is certainly NOT responsible.

The EPA and SafeWork SA are both involved with this issue with prohibition and enforcement notices being issued.





We will keep an eye on the issue.

# NATIONAL WORKERS MEMORIAL

The Australian Government has committed \$3.6 million to the establishment of a National Workers' Memorial in Canberra. The memorial will pay tribute to those who have lost their lives as a result of workplace incidents, accidents and disease.

The memorial will be located in Kings Park on the North shore of Canberra's Lake Burley Griffin and will provide an important focal point for the national commemoration of Workers' Memorial Day, recognised internationally on 28 April each year.

Workplace Relations Minister Bill Shorten unveiled the winning design for the National Workers' Memorial on 14 March 2012 saying it was important to recognise the contribution Australian workers have had in building the nation.

# Speaker outlines asbestos risks

For some it was personal, for some it was an eye-opener, and for others it was a reminder that asbestos is everywhere. The Probus Club on Tuesday was treated to a visit by the Asbestos Victims Association.

The speech was heard by about 60 people including women from the Flinders Ladies Probus Club.

Vice-president of the association Kat Burge opened by telling a story of how president Terry Miller's wife had washed his clothes while he was working for James Hardie. "She is no longer with us, she died from lung cancer," she said.

Mr Miller himself, spoke about how there is no cure for his own asbestos-related problems, but only manage it. Bob Saler, is a member of the association, told of how he had been motivated to find out more about asbestos after his brother lost his life to an asbestos-related disease 12 months ago.

Mr Miller gave motivational presentation that included visual photos of different types of asbestos, where you can find it and how to safely remove it. He spoke about how asbestos can break into invisible fibres that can be breathed in when it is fractured or disturbed.

"Bonded asbestos if in good condition is safe," he said. "It is when you start disturbing the stuff, you also release fibre. "By doing that you start exposing yourself and others to airborne fibres that can become a problem."

For Pat Footner of the ladies Probus club, the presentation brought back emotions. Her husband had contact with asbestos during his days as a boilermaker at the BHAS smelter. He was diagnosed with mesothelioma in 1982 and died after a painful illness in 1984.

"I wish there had been an organisation like the Asbestos Victims Association to support us in our time of need," she said.
